Hand, Registered Professional Engineer, No. 9325, State of Alabama, which locates and identifies UNITS 117 THRU 128, UNITS 157 THRU 170, UNITS 217 THRU 228, UNITS 257 THRU 270, UNITS 317 THRU 329 AND UNITS 357 THRU 372, of said Condominium and locates the Common Elements and Private Elements which are defined in the Declaration of Condominium of Sugar Beach Condominium as same appears of record in Miscellaneous Book 53, Pages 1837, et seq., of the Baldwin County, Alabama, Probate Court Records.
